# 1. Liability Waiver

#### 6. Bicycle Maintenance Responsibility

a. I understand that I am responsible for basic upkeep of the bicycle, including checking tire pressure and ensuring brakes and other parts are in safe and functioning condition. I understand that the City is not responsible for ongoing maintenance.
