

ZOOM WEBINAR - CITY COUNCIL MEETING

How the Meeting will Work

City Council meetings will be held via Zoom Webinar. The City Clerk **hosts** the meeting with assigned staff as co-hosts, Hayward City Council Members and participant City staff are **panelists**, and Hayward residents and public members are **attendees**. Zoom Webinar attendees join in view/listen-only mode and are muted by the host as needed.

How to Provide Public Comment

The City Clerk's office is accepting public comments on behalf of the City Council prior to the meeting via eComment, Email, or Live public comment during the meeting.

eComment: To send your comment directly to Council Members before the meeting starts, please click on <https://hayward.legistar.com/Calendar.aspx> and click on the eComment link for the corresponding meeting

Email: Please add the council meeting date in the subject line such as in the example below.

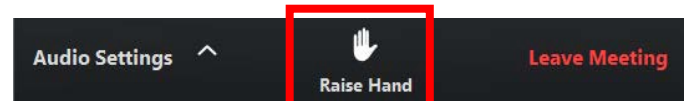
Live Public Comment: If you are unable to provide a written comment, you may access the webinar as an attendee: 1) via the link provided on the agenda, or 2) call into the meeting using your phone by dialing 1-669-900-6833 and entering the Meeting ID (unique to each meeting; see first page of the agenda). To speak during the meeting, press*9 and wait for your turn.

Public Participation Guidelines

We appreciate your cooperation with the guidelines provided below.

- **How to Join:** Visit the Zoom website and either sign-up for a free Zoom account or continue as a guest. Once you have downloaded the app on your smartphone, joined from your web browser, or downloaded the Zoom software on your computer you will be ready for the Council meeting.



- **Raise Hand (pictured above):** click the "Raise Hand" button to request to speak when the Mayor calls for public comment on an eligible agenda item. You will be permitted to speak during your turn and muted after the allotted time.

Click **Lower Hand** to lower it if needed.

When joining via phone, click *9 to raise a hand to speak. We kindly request speakers to mute or turn down the broadcast, when it is their opportunity to speak, as it may cause interference with the speaker system.

- **Use headphones/mic** for better sound quality and less background noise.
- **Decorum:** Please be mindful that virtual meetings are public and will be recorded. All meeting rules of procedure and decorum, including speaker time limits, will apply. The Mayor, via the host, may remove individuals for persistent disruption or any conduct or statements that threaten the safety of any person(s) at the meeting.
